





Technical Programming




 The JSEB Program has developed a more robust & enhanced technical program.

• We have listened to the voices of active JSEB vendors to provide a technical program that includes a roadmap to various avenues of contracting and procurement opportunities.

 UNF provides a PTAC program that allows JSEB'S to understand the dynamics of local, state and Federal contracting opportunities.

- We've created a pathway to assist JSEB'S with understanding how to properly assess bids and estimate the values needed to confidentially put in a bid, as well as how to evaluate and write a proposal.
- Our technical program is currently working with a pilot program with Pivot City that will provide connectivity with other small business programs, which will assist JSEB's to build relationships across the small business spectrum.
- We partner with Florida State College at Jacksonville's Workforce Recovery Training Program to provide workforce training to JSEB vendor owners and staff. Both JSEB vendor owners and staff have to qualify for the program.






FY22 JSEB Scorecard


