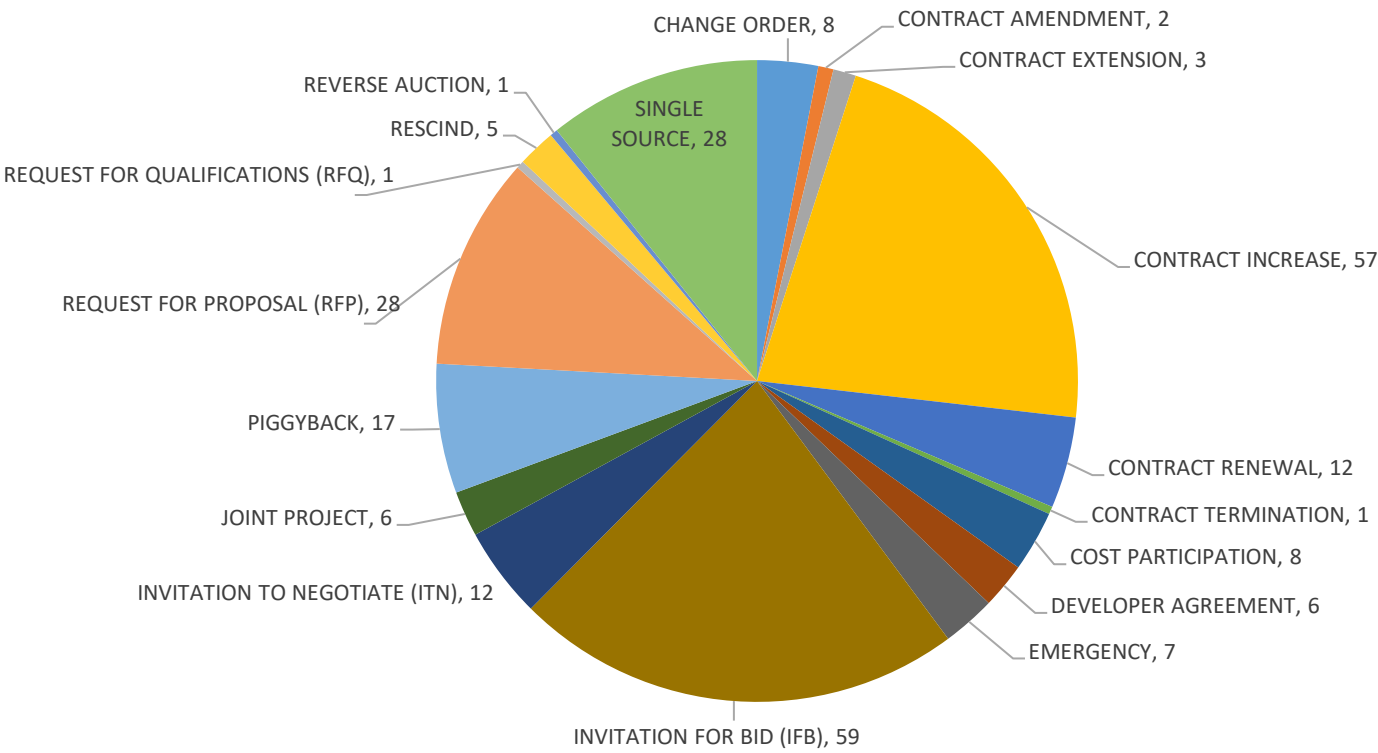




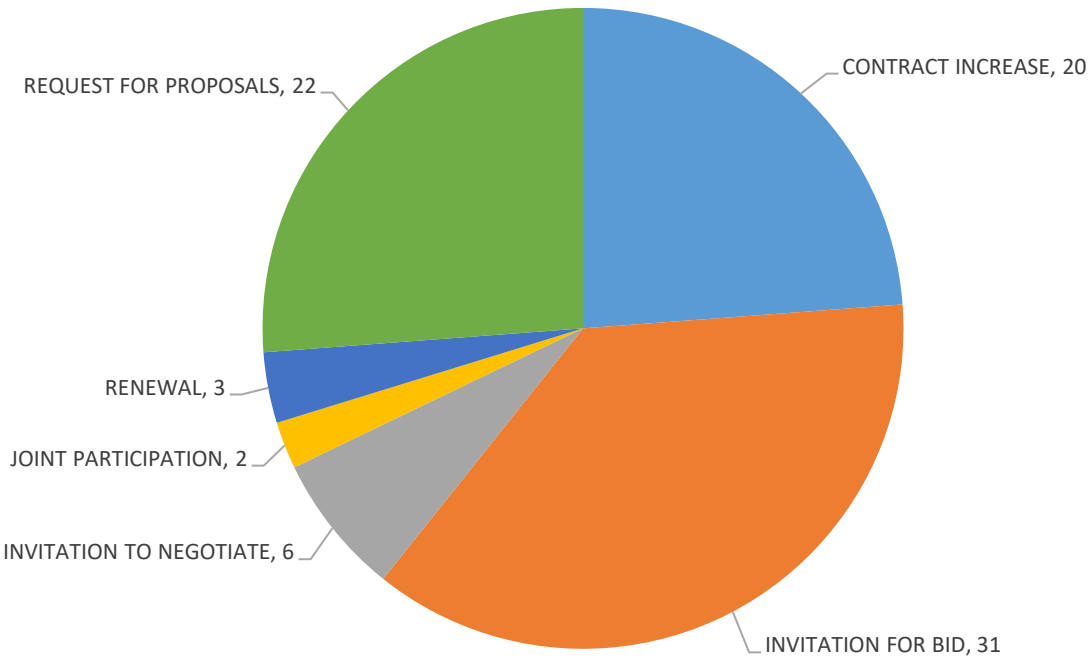

FY25 Annual Supplier Survey Results

JEA's 2025 Annual Supplier Survey shows continued positive trends in its supplier relationships. The number of survey participants increased significantly to 191, a 212% increase from the previous year. This indicates a substantial boost in supplier engagement.

Overall satisfaction saw notable improvements. Overall experience satisfaction increased by 9% compared to the 2024 survey. In the areas of communication, approximately 64% of those surveyed were satisfied or very satisfied. Satisfaction with the overall solicitation process also slightly increased from FY24, with 61% of respondents being either satisfied or very satisfied. Additionally, suppliers view JEA as "responsive, thorough and flexible," and a majority were satisfied or very satisfied with their collaboration experiences. While satisfaction is high, the survey identified some areas for improvement. Suppliers highlighted a need to simplify systems like Zycus and Oracle iSupplier to reduce administrative burdens. They also suggested enhancing small business inclusion by creating tiered vendor lists and pre-qualification opportunities.

Overall, the survey results confirm that JEA continues to maintain a strong reputation as a business partner, with significant increases in participation and satisfaction across multiple key areas. The feedback also provides clear opportunities for JEA to continue refining its processes and systems.

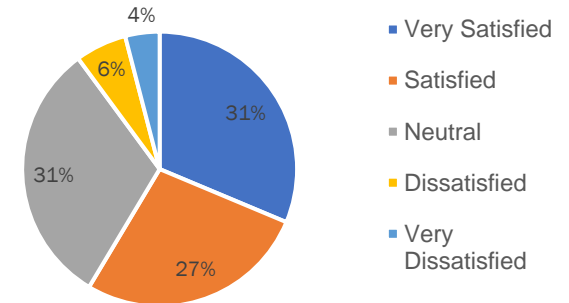

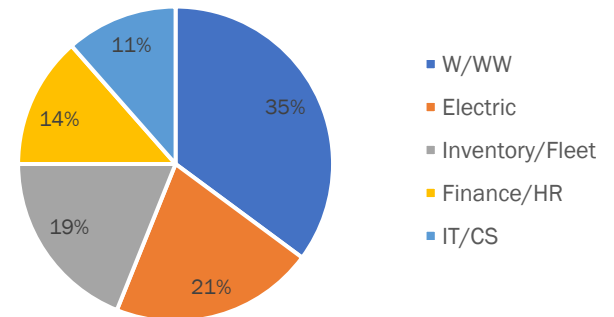

Likelihood to Recommend JEA



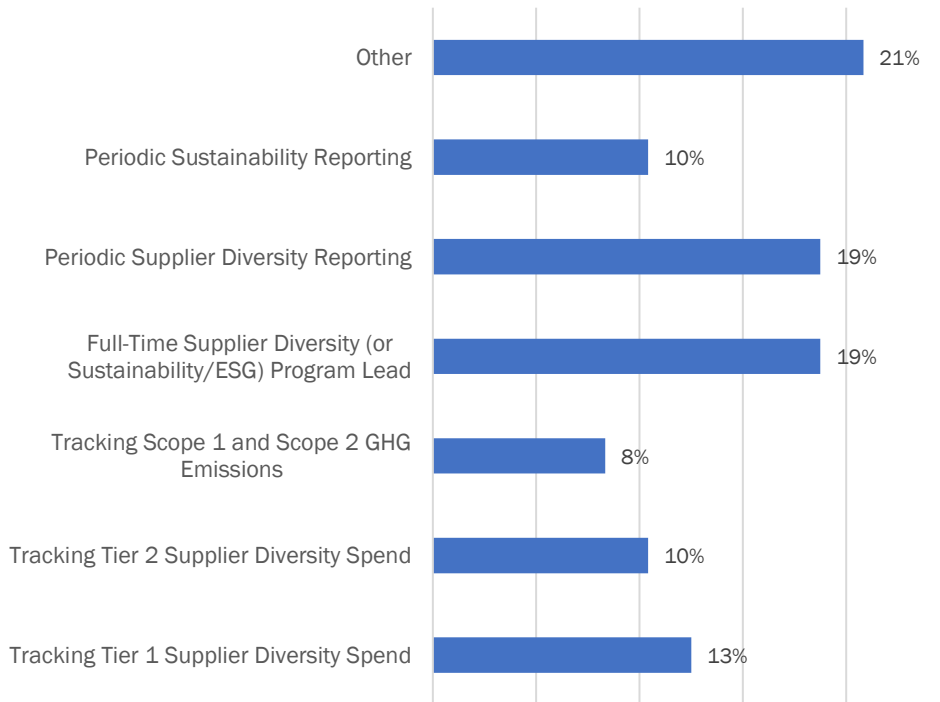

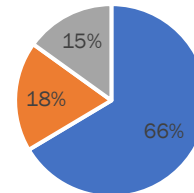

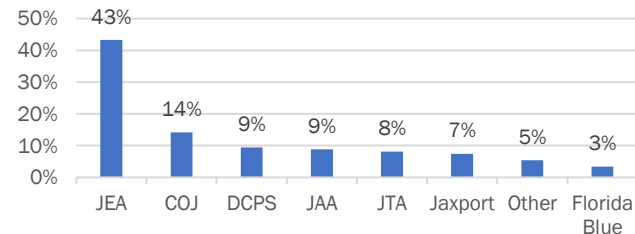

Strengths of JEA Procurement

- Strong partnership approach, with suppliers feeling valued as part of the team and appreciating direct access to leadership through events like the Supplier Summit
- Effective communication via emails on upcoming projects, enabling better planning and forecasting for consultants and suppliers
- Transparent and reliable bidding processes, with positive feedback on contract awards, POs, and overall collaboration

Opportunities to Review

- Simplify systems like Zycus and iSupplier for easier navigation, invoice submission, and supplier onboarding to reduce administrative burdens
- Enhance diversity and small business inclusion by creating tiered vendor lists, pre-qualification opportunities, and criteria for Service-Disadvantaged Veteran Owned businesses
- Revise part numbering and specification standards to align with industry norms, improving clarity and reducing confusion in procurement

Continue to Prioritize

- Proactive predictive maintenance programs to address supply chain issues, rising costs, and equipment availability in plant operations
- Early contractor engagement and alternative delivery methods (e.g. CMAR, design-build) for better alignment on long-lead items and constructability
- Managed security services and vendor vetting to free up internal staff for high-impact work while mitigating cybersecurity risks

Supply Market Outlook

- Increasing adoption of AI and cloud-based solutions for data security, analytics, and operational efficiency, with a focus on self-service tools and autonomous capabilities
- Shift toward grid hardening, including larger utility poles and steel replacements for wood, driven by sustainable forestry and coastal resilience needs
- Growing emphasis on energy efficiency, demand response, and smart infrastructure like SCADA integration and EV chargers to meet rising electricity demands
- Expansion of PFAS treatment regulations and wastewater remediation technologies, alongside digitalization for smart utility networks

Supply Market Risks

- Persistent tariffs on raw materials and components, leading to cost increases and potential shortages in items like electrical gear and poles
- Labor shortages, particularly for skilled trades such as welders, engineers, and field staff, exacerbating project delays and resource availability
- Extended lead times for critical equipment (e.g., switchgear, valves, and instrumentation) due to global supply chain disruptions and manufacturing bottlenecks
- Economic uncertainties, including inflation, market consolidation, an potential policy changes affection CAPEX projects and material costs
