THIS ADDENDUM IS FOR THE PURPOSE OF MAKING THE FOLLOWING CHANGES OR CLARIFICATIONS:

1. **A supplier asked, "Can you help me understand what you require or currently have for the "overload alarm/warning and load display?"**

Digital readout with the weight of the load. OEM or Aftermarket will be acceptable.

2. **A supplier asked, "We noticed on page 6 of the solicitation in section 1.1.1. Scope of Work that it lists for Group 3 that you are requesting a 3,000 lbs. Forklift Reach Truck. On the page titled Specification, JEA Class 361R Forklift Reach Truck, Electric – Section 3. Dimensions & Weight – the bid lists that you require a 3,500 lbs. – 3,800 lbs. Capacity. Could you please clarify which capacity is required for the Electric Reach Truck? Is it 3,000 lbs. or is it 3,500 lbs. - 3,800 lbs.?"**

The requirement for the lift capacity is between 3500 lbs. & 3800 lbs. The minimum lift capacity is 3500 lbs. and the maximum lift capacity is 3800 lbs. so any quotes within that specified range will be accepted.

3. **Section 1.1.1 Scope of Work of the solicitation has been adjusted to the following language.**

The purpose of this Invitation for Bid (IFB) is to solicit pricing for the purchase of vehicles for the forklift vehicle classes for JEA's Fiscal Year 21 (Oct 2020 to September 2021) requirements as described in Appendix A to this IFB. All units must be tested and delivered to JEA Fleet Facility (5717 New Kings Road Jacksonville, Florida 32209) in complete operational condition. JEA has grouped these vehicles into three (3) groupings identified below.

Group 1

- FORKLIFT 5000 LBS.

Group 2

- FORKLIFT 10000 LBS.

Group 3

- FORKLIFT REACH TRUCK 3500 LBS. – 3800 LBS.

Within the various vehicle groupings and for those vehicles that are assigned to JEA's FY 21 requirements (October 2020 to September 2021), if the Company fails to complete delivery and obtain JEA's Acceptance of the goods on or before September 1, 2021, the Company shall pay JEA the sum of \$25.00 per unit per day for each and every calendar day, including Sundays and Holidays, starting on this day until the date delivery is complete and Accepted by JEA. Delivery cannot occur prior to October 1, 2020.

A more detailed description of the Work is provided in the Technical Specifications included as Appendix A to this Solicitation.

Capitalized terms used in this Solicitation without definition shall have the definitions given to them in Section 2.2 of this Solicitation.
