THIS ADDENDUM IS FOR THE PURPOSE OF MAKING THE FOLLOWING CHANGES OR CLARIFICATIONS:

1. The title of this solicitation has changed to ITN Primary, Secondary, and Fiber Optic Wire and Cable for JEA Inventory Stock.
2. The Response Due Date has been extended until November 20, 2018 at 12:00 P.M. Eastern. All Responses shall be publicly opened and recorded on November 20, 2018, AT 2:00PM Eastern, at the JEA Bid Office, 21 W. Church Street, Customer Center 1st Floor, Room 002, Jacksonville, FL 32202.
3. Section 1.2.4.1 of the Solicitation titled "Quotation of Rates" has been updated with the following changes.
 - Incorporates a Primary and Secondary Award for this Solicitation for all JEA Item IDs.
4. Section 1.3.2 of the Solicitation titled "Tie" has been added in its entirety.
5. Section 2.4.6 of the Solicitation titled "Price Adjustment-Quarterly" has been updated with the following changes.
 - Changed the Anniversary Date as it relates to pricing adjustment to three months after October 26, 2018 which shall be referred to the "Anniversary Date".
 - Provided specific numbers for the Aluminum Bases, Copper Base, and Plastic & Resin Base for suppliers to base their initial unit bid prices on.
6. An updated Solicitation labeled "006-19 Secondary Wire and Cable for JEA Inventory Stock – Addendum 3" is attached to reflect these changes noted above in a tracked changed format.
7. An updated Appendix C labeled "006-19 – Appendix C – Addendum 3" is attached. The Base Price conversion table was adjusted in order to add in the proper formula adjustments for CU and AL when making quarterly price changes.
8. The below are supplier asked questions along with JEA's answer back to the questions.
 - **Okonite Cable shows approved for line item CAICL001. Okonite only manufacturers EPR cable for this cable type though your description only states XLPE cable. Would Okonite Cable be approved for purchase if low bid? Would this also be true for the other cable types that show Okonite cable?**

JEA is reviewing this question and will respond back once finalized.

- **Bid documents do not specify base indexes, can you please provide an example how JEA plans to evaluate each line item for price comparison against the different manufacturers to determine best overall ranking by price?**

When submitting the initial unit price for the listed items within Appendix A – Response Workbook, the base price that shall be used for AL and CU shall be the reported weekly figures from PLATTS as of October 26, 2018 as noted below. The AL figure that should be used is 1985.80 for LME Settlement and 19.67 for MW US Transaction Premium. The CU figure that should be used is 275.20 for COMEX HG 1st Position. The base price that shall be used for the Plastic & Resin Base shall be the August 2018 PPI data that was released on October 10, 2018 with an index of 290.6.

- **In THE second addendum you stated you will be adding a second tier supplier. Is the awarded second tier vendor obligated to inventory the same cable quantities for both storm and daily use as the awarded first tier supplier?**

The backup supplier will not have the same obligation to inventory the same cable quantities for both storm and daily use as the awarded primary supplier

- **Is JEA still accepting standards approval requests for manufacturers currently not shown approved on the bid?**

Vendors can continue to work with the Electrical Standards team to review new products to get approval to use within our network. Approval must be granted by November 7, 2018 to be considered as part of this bid and the bid workbook will be updated accordingly.
