THIS ADDENDUM IS FOR THE PURPOSE OF MAKING THE FOLLOWING CHANGES OR CLARIFICATIONS:

1. JEA is updating section 1.1.4 Pre-Bid Meeting

1.1.4. OPTIONAL PRE-BID MEETING IN PERSON OR TELECONFERENCE

There will be a ~~mandatory~~ optional Pre-Bid meeting. All interested Bidders ~~must~~ should attend the Pre-Bid meeting

2. JEA is updating section 1.2.1 Minimum Qualifications as shown below:

1.2.1. MINIMUM QUALIFICATIONS FOR SUBMISSION

Bidder shall have the following Minimum Qualifications to be considered eligible to submit a Bid in response to this Solicitation. It is the responsibility of the Bidder to ensure and certify that it meets the Minimum Qualifications stated below. A Bidder not meeting all of the following criteria will have their Bids rejected:

- One (1) project shall have been self-performed for a water, sanitary sewer, or reclaim water main by the open cut method, with a minimum of 5,000 linear feet of PVC or ductile iron pipe of ~~twelve~~ sixteen inches (16”) or greater.

3. JEA is updating section 2.7.1 Insurance Requirements as shown below:

2.7.1. INSURANCE

INSURANCE REQUIREMENTS

Before starting and until acceptance of the Work by JEA, and without further limiting its liability under the Contract, Company shall procure and maintain at its sole expense, insurance of the types and in the minimum amounts stated below:

Workers' Compensation

Acknowledge receipt of this Addendum on the Proposal Form (Appendix B)

Florida Statutory coverage and Employer's Liability (including appropriate Federal Acts); Insurance Limits: Statutory Limits (Workers' Compensation) \$500,000 each accident (Employer's Liability).

Commercial General Liability

Premises-Operations, Products-Completed Operations, Contractual Liability, Independent Contractors, Broad Form Property Damage, Explosion, Collapse and Underground, Hazards (XCU Coverage) as appropriate; Insurance Limits: \$1,000,000 each occurrence, \$2,000,000 annual aggregate for bodily injury and property damage, combined single limit.

Automobile Liability

All autos-owned, hired, or non-owned; Insurance Limits: \$1,000,000 each occurrence, combined single limit.

Excess or Umbrella Liability

(This is additional coverage and limits above the following primary insurance: Employer's Liability, Commercial General Liability, and Automobile Liability); Insurance Limits: \$4,000,000 each occurrence and annual aggregate.

Company's Commercial General Liability and Excess or Umbrella Liability policies shall ~~be effective for two years after Work is complete.~~ **remain in force throughout the duration of the project and until the Work is completed to JEA's satisfaction.** The Indemnification provision provided herein is separate and is not limited by the type of insurance or insurance amounts stated above.
