
### 1. SCOPE

It is the intent of the JEA to purchase **FOUR (4)** 5T 6X4 14 to 16 CUYD DUMP TRUCKS with **66,000 LB GVWR**. All units must be tested and delivered to JEA Fleet Facility (5717 New Kings Road Jacksonville, Florida 32209) in complete operational condition, with all required equipment and documentation by **September 20, 2018**. Liquidated Damages (\$44.37 A Day, Per Unit) start **September 20, 2018** 

### 2. MODEL:

New, current model year production Class-8 (Freightliner M2-112, International HX620, Kenworth T880, MACK Granite or Equal with OX BODY Model 14FT 13/15YD Dump Bed). Reference: JEA Unit # 70023 for General Layout and Dimensions.



### 3. CAB / CHASSIS

- 3.1 **Class-8:** 6X4 with **66,000 LB** GVWR.
- 3.2 Conventional Cab
- 3.2 **CA:** Not to Exceed **112""**
- 3.3 **WB:** Not to Exceed **180** "
- 3.4 **Overall Height:** From Level Ground to Highest Point on Vehicle Not to Exceed **130**".
- 3.5 **Overall Length:** Not to Exceed **302**".
- 3.6 **Max Speed: 72 MPH.**

- 4. ENGINE (REQUIRE DETROIT DD13, MACK MP8, PACCAR MX13, DETROIT DD15 OR CUMMINS X15, DUE TO RELIABILITY / DURABILITY) 4.1 HORSE POWER: MINIMUM 450 HP.
  - 4.2 **Torque Range:** Minimum **1450 lbs**. to **1750 lbs**.
  - 4.3 **No** Automatic Idle Shutdown.
  - 4.4 Block Heater.
  - 4.6 Engine warning and shut down system.
  - 4.7 IDLE UP / Remote Throttle Option

- 5.1 ALLISON RDS 4500.
- 5.2 Power Take Off.

### 6. REAR AXLES

- 6.1 Air Ride / 46K with manual dump valve (Rated for Required GVWR and Application).

7.1 **20,000 lb.** with Oil Bathed Bearing/Hubs (Rated for Required GVWR and Application).

### 8. TIRES

- 8.1 **FRONT:** Floater **425 / 65 R22.5** Rated for GVWR.
- 8.2 **REAR:** 11R 22.5, **726 EL** Rated for GVWR.

## 9. BRAKES (AIR BRAKES)

- 9.1 **Air Disc Brakes with Shields:** Front and Rear Axles.
- 9.2 Anti-lock braking system.
- 9.3 Automatic drain valves with manual pull cables.
- 9.4 Air Dryer.
- 9.5 Low air pressure warning system.
- 9.6 Trailer Hand Valve (Trailer Air Brakes)

### 10. COOLING SYSTEM

10.1 Heavy duty extra cooling capacity, largest available from manufacturer.

### 11. FUEL TANK

11.1 CAPACITY: MINIMUM 120 GALLONS. DUAL TANKS ARE ACCEPTIBLE.

### 12. CHASSIS ELECTRICAL AND LIGHTING (NO SCOTCH LOCK CONNECTIONS)

- 12.1 **Meters:** hour meter, transmission temperature, engine oil pressure, engine temperature, charging system, fuel level, air pressure and diesel exhaust fluid level (In Cab / Instrument Cluster).
- 12.2 Auxiliary / Accessory Lugs wired with Resettable Breaker (Mount inside Cab and Accessible): To Wire JEA Installed COMPONENTS such as GPS, Fuel Rings & Etc. See Example Below

12.3 MASTER SWITCH WITH LOCKOUT/TAGOUT: In Cab (Mitigate Dead Batteries Due To GPS, Fuel Rings & Etc.).

EXAMPLE: TR SERIES DUAL POLE MASTER DISCONNECT SWITCH (500A • DPST • IP67/IP69k • Integrated Lock-Out Tag-Out).



12.4 All Cab / Chassis Lights: LED ONLY.

12.5 **Auxiliary Battery Jump Ports:** Insulated remote posts protected and mounted close to batteries underneath cab body / accessible.



12.6 **DC Accessory Power Outlets**: 3 DC power outlets in cab for accessories with spring loaded cover (For Cell Phone Chargers & Etc.). See example below (NAPA Part Number & Picture): NAPA Part # BK 7821773 or equal.





- 12.7 **Power Package:** Power Windows, Locks, Mirrors (Heated) and Cruise Control.
- 12.8 **Backup Camera:** 7" Color Screen with Sound and Infa Red Night Vision Mounted To Overhead Console.
- 12.9 AM / FM / Weather Band Stereo with Auxiliary Input, and BLUETOOTH HANDS FREE.
- 12.10 Factory installed air conditioner and heater.
- 12.11 **OEM UP-Fitter Switches (Located Upper Console or Dash):** To Wire all Dealer Installed Items such as Strobe Lights and Etc.
- 12.12 **LED Strobe Lights (6 COUNT):** One on All 4 Corners (4 Total) and One on each side of the Dump Body/Centered (2 Total).
- 12.13 Back Up Alarm

## 13. ADDITIONAL REQUIRED EQUIPMENT/OPTIONS

- 13.1 Tilt Wheel.
- 13.2 Front Bumper.
- 13.4 Air Ride Drivers Seats with Collapsible Armrest (70/30 Seat).


- 13.11 Interior / Forward / Roof Mounted Console: Storage compartments.

- 16.3 (1) On-Site JEA Operator Orientation Classes (Complete Unit).
- 16.4 (1) On-Site JEA Maintenance Orientation Classes (Complete Unit).
- 16.5 Include a paper copy **Specification / Build Sheet / Drawings** in all units including Key Codes.

17.1 Drawings will be provided to JEA upon receipt of order. Drawings will include all interior and equipment layout details. Final Drawings / Layout will be approved by JEA.

### 18 WARRANTY

18.1 Minimum (1) One Year warranty on Chassis & All Attachments (Parts, Travel & Labor). Must include all standard manufacturer warranties.

#### 19 OTHER REQUIREMENTS

- 19.1 Purchase / Install CITY License Plates.
- 19.2 **Install JEA Provided Branding / Decals:** You may solicit JEA's current vendor Graphics Applications Systems, at your expense.

- 19.3 Install JEA Provided/Required Safety Equipment: Purple-K Fire Extinguisher (5 lb.), JEA First Aid Kit and Key Safe.
- 19.4 **Current DOT Inspection / Certification:** Complete with Decal installed lower left inside corner of windshield.
- 19.5 Must include/document the Vin Number, Make, Model, Description, JEA PO # and JEA Provided 5 Digit Unit Number on all Invoices and Change Order Invoices.



19.6 Reflective Roadside Triangle Warning/Hazard Kit.
