- The Bidder shall have successfully completed two (2) similar contracts, or be in successful process performing a project, (equipment must be past factory acceptance testing) in the previous five (5) years, date ending January 31, 2018. A similar contract is defined as a U.S. power generation gas turbine exhaust duct silencer replacement project of greater than \$500,000.00. (at least one of which shall have been a GE frame 7.)
  - Additionally, JEA may request a design review and additional project references to validate the company's ability to perform the work. JEA reserves the right to approve to reject the company on the basis of any findings from a design review or reference check.

Please note, any Bidder whose contract with JEA was terminated for default within the last two (2) years shall have their Bid rejected.
