**THIS ADDENDUM IS FOR THE PURPOSE OF MAKING THE FOLLOWING CHANGES**

**CHANGE:** The Bid Due Date has been changed to: June 19, 2018, 12:00 PM (NOON EST).

**ADD:** An Additional Mandatory Pre-bid meeting will be held on May 22, 2018, 9:00 AM at the JEA Customer Center, First Floor, Room 002, 21 West Church Street, Jacksonville, FL 32202. Companies that attended the first Mandatory Pre-bid meeting are not required to attend the second Pre-bid meeting.

There will be OPTIONAL site visits, immediately following the Pre-bid meeting. Companies are required to bring their own personnel protective equipment (hard hats, safety shoes, glasses and hearing protection).

**ADD:** The Argyle/Rampart Road Equipment Attribute worksheet for specification section 01731 Asset Management Data, has been added to this Addendum 1. The Contractor shall assume the same level of effort for Bradley Road.

**CLARIFICATION: ON MINIMUM QUALIFICATIONS FOR SUBMISSION**

- All four (4) projects must meet the following minimum criteria:
  - Greater than \$8,000,000.00 project
  - Shall have been successfully completed in the last ten (10) years, date ending the Bid Due Date.

**\*\* Note:** this requires the company submit four total projects that meet the above criteria.
- Two (2) of the submitted projects shall be wastewater booster pump station construction projects of similar flow, and one to have included an enclosed structure.
- One (1) of the submitted projects shall have had large diameter piping (greater than 20" at depths of 12'+ below grade).

**\*\* This project does NOT have to be a wastewater booster pump station project. However, shall be greater than \$8,000,000.00 in value and successfully completed in the last ten (10) years, date ending the Bid Due Date.**
- One (1) of the submitted projects shall have included dewatering (sheeting and shoring to depths greater than 16' below grade).

**\*\* This project does NOT have to be a wastewater booster pump station project, however, shall be greater than \$8,000,000.00 in value and successfully completed in the last ten (10) years, date ending the Bid Due Date.**

**REPLACE:** The Minimum Qualification Form attached to this Addendum 1, replaces the Minimum Qualification Form issued with original Solicitation. The wording regarding “demolition” has been struck from the Minimum Qualification Form.
