THIS ADDENDUM IS FOR THE PURPOSE OF MAKING THE FOLLOWING CHANGES OR CLARIFICATIONS:

1. **CHANGE:** Section 1.2.1. Minimum Qualifications for Submission has been revised to show the following changes in bold and highlighted below. A revised Appendix B Minimum Qualification form is included with this addendum.

1.2.1. MINIMUM QUALIFICATIONS FOR SUBMISSION (RFP)

Proposer shall have the following Minimum Qualifications to be considered eligible to submit a Proposal in response to this RFP. **Appendix B Minimum Qualification Form has been provided to complete this section.**

It is the responsibility of the Proposer to ensure and certify that it meets the Minimum Qualifications stated below. A Proposer not meeting all of the following criteria will have their Proposals rejected:

The Proposer shall have successfully completed two (2) similar new or expansion projects in the past seven (7) ten (10) years as of the RFP due date.

- One (1) project must include the design of at least one (1) chilled water plant with a capacity of 4,000 tons each with at least two (2) separate connections. The facility must include thermal storage along with emergency generator back-up for operation of the chilled water plant.
- One (1) Two (2) projects, both of which must include the design of at least one (1) new chilled water plant OR one (1) expansion, each project consisting of at least one (1) water-cooled chiller having a minimum capacity of 1,500 tons, associated pumps and cooling tower new or expansion/addition. One (1) of the projects must include thermal storage and one (1) of the projects must include backup generation.

NOTE: One of the two (2) projects above must include a minimum of 1,000 linear feet of chilled water lines within a public or private vehicle right-of-way. The 1,000 linear feet is defined as serving a customer that is at least 500 feet from the production facility.

Please note, any Proposer whose contract with JEA was terminated for default within the last two (2) years shall have their Proposal rejected.
