**THIS ADDENDUM IS FOR THE PURPOSE OF MAKING THE FOLLOWING CHANGES OR CLARIFICATIONS:**

**SUPPLIER INQUIRY 1:** Can you confirm that the 20 page limit applies specifically to the design approach section? Is there a limit on the total number of pages for the complete submittal?

**JEA RESPONSE 1:** Yes the section 1.2.6.2 DESIGN APPROACH AND WORK PLAN states

“Proposer 's response to item above should be limited to no more than twenty (20) pages, 1-sided, single-spaced , on 8.5” x 11” sized paper . Please use your own form for this Section. Responses that are longer than twenty (20) pages will not be evaluated after page twenty (20).”

This statement applies specifically to this section.

**ADD:** The following section 1.2.6.7 TOTAL RESPONSE SUBMITAL LENGTH to the solicitation.

**1.2.6.7 TOTAL RESPONSE SUBMITTAL LENGTH**

The Proposal submitted in Response to this ITN shall be no longer than fifty (50) pages in length, including all JEA required forms and documentation.

**REPLACE:** The following section 1.2.6.5 JSEB Criteria replaces the section 1.2.6.5 JSEB Criteria issued with the original solicitation.

**1.2.6.5 JACKSONVILLE SMALL AND EMERGING BUSINESS (JSEB) - RFP**

**Maximum score for this criterion is: 5 POINTS**

NOTE: The specific JSEB **requirement** for the design and permitting portion of the project is **TEN PERCENT (10%)** JSEB participation. Companies are required to fully comply with the JSEB program as described in 1.9.2.1.

Proposer shall indicate if it is certified as a Jacksonville Small and Emerging Business (JSEB) as defined by Jacksonville Ordinance 2004-602; Chapter 126, Part 6A and 6B.

If Proposer is not a certified JSEB, the Proposer shall list the JSEB certified subcontractors that it intends to utilize in the performance of this Work. The listing should include names of the JSEBs, the type of service they will provide, and the percentage of work being subcontracted. Points will be awarded based on the type and amount of work that will be conducted by JSEB firms.

NOTE: Points will be awarded for Proposers that include additional participation above the required JSEB participation of ten percent (10%).

The points will be awarded as follows:

Proposer is a COJ/JEA certified JSEB = 5 pts;

Non-JSEB with JSEB partner:

Greater than or equal to 20% of work = 4 pts

Greater than or equal to 15%, but less than 20% of work = 3 pts

Greater than 10%, but less than 15% of work = 2 pts

10% = 1 pts

**REPLACE:** The Evaluation Matrix attached to this Addendum 2, replaces the Evaluation Matrix issued with the original solicitation. The changes on the Evaluation matrix are due to rescaling the JSEB percentages.
