THIS ADDENDUM IS FOR THE PURPOSE OF MAKING THE FOLLOWING CHANGES OR CLARIFICATIONS:

 Section 1.1.1 Scope of Work of the Solicitation is updated to the following language which removes the reference of the Class 130 - Van One-Ton Cargo Dually Diesel 4X4 and Class 130 - Van One-Ton Cargo Mid Height Ladder Rack

The purpose of this Invitation to negotiate (the "ITN") is to solicit pricing for the purchase of eighty-two vehicles within the vehicle class categories of 115, 116, 117, 119, 122+, 123, 130, and 136 for JEA's FY 20 requirements for both replacement and expansion projects for the Electric and Water departments. All units must be tested and delivered to JEA Fleet Facility (5717 New Kings Road Jacksonville, Florida 32209) in complete operational condition, with all required equipment and documentation by September 25, 2019. JEA has grouped these vehicles into six (6) groupings identified below.

Group 1:

- Class 115 SUV 4X4
- Class 116 Half-Ton 4X2 Standard Cab Pickup Trucks
- Class 117 Half-Ton 4X4 Crew Cab Pickup Trucks
- Class 117 Half-Ton 4X4 Standard Cab Pickup Trucks
- Class 119 One-Ton 4X4 Extended Cab SRW LWB Pickup Trucks

Group 2:

• Class 122+ - One-Ton 4X4 SRW Extended Cab Utility Body Trucks

Group 3:

- Class 123 Truck One-Ton Utility 11'
- Class 136 Truck One-Ton 4X4 Stake/Liftgate 16'

Group 4:

Class 123 - Truck One-Ton Utility 7500 LB Boom 11'

Group 5:

- Class 123 Truck One-Ton Extended Cab Utility Compressor 11'
- Class 123 Truck One-Ton Utility Valve Machine 9'

Group 6:

• Class 130 - Van One-Ton Cargo Mid Height

- 2. The document labeled "139-19 Appendix B FY20 Light and Medium Duty Vehicle Procurement Acquisition" has been deleted in its entirety and replaced with the document labeled "139-19 Appendix B FY20 Light and Medium Duty Addendum One" attached to this addendum. Below are the changes that were made to the document.
 - Group 2
 - o All six (6) Units in Group 2 are the same, OPTION A.
 - There is no Standard Specification requirement for this Group for this bid.
 - Group 6
 - The reference for "Dually Diesel 4X4" has been removed in its entirety and replaced with "Cargo Mid Height"
 - o There are no Standard Specification requirements for Group 6, as the nine total vehicles are either Option A, B, or C.
