- 3. Question: "Can one of the 10 pages of the approach be included as 11 x 17?"

Answer: Yes.

4. Question: "This statement is made in the Appendix C, Page 6 of 37, Paragraph 1. Final Water Quality Monitoring Station scope/design will be in alignment to the final design of the water quality monitoring stations designed in 102-34: SIPS Deerwood Project. Please provide the latest design milestone of this projects design (drawings and specifications) so we can have an understanding of the current design at Deerwood."

Answer: JEA has received the 90% design submittal, however the submittal has not been reviewed. The un-reviewed 90% submittal can be found as the following files.

- 5. Question: "Please provide the current design milestone (either 60% or 90%) of the 102-34 SIPS Deerwood plan and profile pipeline drawings for review particularly the interconnections at Deerwood WTP (how that is arranged) as well as the stub out on Burnt Mill Road."

Answer: The 90% design submittal has been received by JEA, but not reviewed. Please see the files listed in the answer of item 4 of this addenda for the drawings.

6. Question: "Can a person in a primary position serve as a backup in another position?"

Answer: Yes. A person in a primary position can serve as backup in one other position.

7. Question: "Can you please confirm the language in section 2.7.2?"

Answer: Section 2.7.2 Indemnification is updated as shown below.

2.7.2. INDEMNIFICATION

Company shall hold harmless, indemnify, and defend JEA against any claim, action, loss, damage, injury, liability, cost and expense of whatsoever kind or nature (including, but not by way of limitation, reasonable attorney's fees and court costs) arising out of injury (whether mental or corporeal) to persons, including death, or damage to property, arising out of or incidental to the extent caused by the negligence, recklessness or intentional wrongful misconduct of the Company and any person or entity used by Company in the performance of this Contract or Work performed thereunder. For purposes of this Indemnification, the term "JEA" shall mean JEA as a body politic and corporate and shall include its governing board, officers, employees, agents, successors and assigns. This indemnification shall survive the term of a Contract entered into pursuant to this solicitation, for events that occurred during the Contract term. This indemnification provisions set forth elsewhere in this Contract.

8. Question: "Can you confirm the insurance limits in section 2.7.1?"

Answer: Confirmed.
