  - Question: JEA received several questions relating to specific contract terms.
    - Response: JEA is open to review contract changes and “redlines” with a respondent once the top ranked firm has been selected and engaged in negotiations.
  - Question: The Solicitation indicates that “The Company must be listed on JEA’s Qualified Proposers List in the following category, as of the Proposal due date: WE4 – Water, Sewer and Reclaimed Water Pipe Less than 24 Inches.” Will JEA be able to

pre-qualify a firm that recently submitted its prequalification application after the solicitation was released?

- Response: Yes. Respondents will be notified of their application status prior to the Response Due Date.
- Question: During the preproposal meeting, JEA indicated that the selected firm can perform up to 20% design work. Can JEA confirm this percentage?
  - Response: Yes, as detailed in the document titled “1411453446 Addendum 1 Appendix A - Technical Specifications,” the Program Manager can perform 20% of the design work annually.
- Question: Can a subconsultant to the selected firm submit proposals on solicitations for projects under the program?
  - Response: Yes, for example a subconsultant who performs utility design could also be selected to perform construction inspection.
- Question: Would the JEA consider extending the proposal submittal deadline by 14 days?
  - Response: Yes. JEA is extending the Due Date to November 28, 2023.
