2. **Question:** Referencing Workbook Tab A - Cost Plus %. We use manufacturers suggested list price. There is no set margin, it is variable. How do we input the percentage, because it cannot exceed 20%.

Answer: The markup will be on parts that are not carried by the proposing company. For example, if a John Deere part is needed for a repair, 20% is the maximum mark up.

3. Question: For special order parts, are we allowed to charge freight?

Answer: Yes. Reference Technical Specifications section 7. Pricing Definitions which states, "Appropriate freight charges on special order parts may be charged as a pass through with prior approval."
