3. JEA updating the minimum qualifications as specified below:

Respondent must meet the following Minimum Qualifications to be considered eligible to have its Response evaluated by JEA. Respondent must complete and submit the Minimum Qualification Form provided in this Solicitation. Respondents that are working or have worked for JEA in the past 2 years involving similar work must submit JEA as a reference. JEA reserves the right to ask for additional back up documentation or additional reference projects to confirm the Respondent meets the requirements stated above.

JEA may reject Responses from Respondents not meeting all of the following Minimum Qualifications:

~~I. Respondent shall have successfully completed two (2) similar contracts which has been performed in the last 24 months, date ending the bid due date.~~

I. Respondent shall have successfully completed **one (1)** similar contract/project which has been performed in the last **36 months**, date ending the bid due date. **Similar projects/contracts are required to include the following:**

1. Pressured pipe (potable water pipe larger than 4-inch) installed in a trenchless manner
2. Utilized rigid-rod equipment (Horizontal Directional Drilling – HDD or static pipe bursting)
3. New pipe depth no more than 5 feet deep.
4. Must have included the use of a temporary potable water main to keep customers in service
5. Must have included the FDEP approved pre-chlorination process for the new pipe.
6. Submitted project shall be no less than 1500 LF.

Any Respondent whose contract with JEA was terminated for default within the last two years shall have its Response rejected.
