- 1. Question: Are subcontractor and JSEB contractor EMR's for previous year or 3-year average?

Answer: 3-year average.

2. Question: Can JEA projects be listed as Similar Project references?

Answer: JEA projects can be used. See section 1.15 on the solicitation for details.

3. Question: On the Workbook, the 10% calculation for Supplemental Work Authorization does not appear to be working on my spreadsheet

Answer: This item has been removed from 1412012050 Addendum 3 Appendix B – Bid Workbook.

4. Question: Line 42 The "Markup for Subcontractor" will be a percentage, not a number.

Answer: This item has been removed from 1412012050 Addendum 3 Appendix B – Bid Workbook.

- **5. Question:** Can the following units be added or modified?
 - Mob/demob per jobsite for a 4-man crew should be added
 - Added 4 units for Mob & Demob (L01 L03)
 - An additional unit for size of manlift one for a 45 ft manlift or below, and one for a 65 ft manlift and below. Contractor should be given the option of using the 153 hours of bucket truck OR 45 ft manlift in the unit pricing for purposes of bid. Bucket trucks are SELDOM used inside of substations. Manlifts are the equipment of choice.
 - Amended Unit removed old manlift unit
 - add Units for Rough Terrain Telehandler Forklift 5k lb rated
 - Added Unit (E14)
 - add unit for Rough Terrain Telehandler Forklift 8k lbs rated
 - Added Unit (E15)
 - add Welder, Straight time
 - o Added Unit (L14)
 - add Welder, 1.5 x straight time
 - Added Unit (L15)
 - Boom truck 28 ton or below (this should be a highlighted unit in the bid with hours similar to manlift) Manlifts are not legal lift devices, they are only legal for men and hand tools. You have to have a forklift or a boom truck to perform a legal lift.
 - add Dually (1 ton) Pick-up Truck
 - o Added Unit (E13)
 - add Tool trailer
 - Added unit per day (E45)
 - add Dumpster 20 yard rolloff
 - Added unit per day (E46)
 - add Connex Box 20 ft
 - Added unit per day (E47)

Answer: Units have been added or revised as noted above in bold and on 1412012050 Addendum 1 Appendix B – Bid Workbook

- **6. Question:** Can the following Contract Definitions be modified?
 - 007 after concrete removed, vacated area must be backfilled and compacted back to original elevation prior to rock (unit 016) being added.
 - Clarified unit definition
 - 009 ditto
 - Clarified unit definition
 - 016A temporary removal/reinstall of existing rock per cubic yard (this is removing and piling existing rock in a station so work can begin)
 - Unit 16 is for additional rock to be added to substation. Removing, piling, and refiling existing rock should be factored into the bid for the other relevant units.
 - 019 3 and 4 inch conduit has to be deeper than 18 inches for the below grade sweeps to be correct as they get above grade
 - o Adjusted to 24"
 - 020 ditto, not deep enough
 - Adjusted to 48"
 - 18,19 and 20 imply JEA furnishing conduit, but it is not clearly stated.
 - **O Clarified definition. Contractor supplies materials.**
 - 21 and 22 imply JEA furnishing ground wire.
 - o Clarified definition. Contractor supplies materials.
 - 25 implies JEA furnishing rods
 - Clarified definition. Contractor supplies materials.
 - 29 Contractor furnished terminators? All others by JEA
 - Clarified definition, JEA supplies connectors
 - 32 JEA or Contractor furnish?
 - Clarified definition, Contractor supplies cable.
 - 33- Contractor furnish?
 - Clarified definition, Contractor supplies cable.
 - 36 thru 41 Transport to where?
 - Clarified
 - 62 transport to where?
 - Clarified
 - 64 where
 - Clarified
 - 92 there is typically a Mirafi/Tensar that sits under any GeoWeb.

7. Question: Concrete and asphalt material, is the material to be included in the unit? Or will it be reimbursable?

Answer: Material reimbursement is for items not specifically listed in the units or units that specifically call out to use it (i.e., AC Panels).

8. Question: Will this contract keep a crew working year-round?

Answer: Jobs will be sent on an as-needed basis.

9. Question: Are there any units that could be priced not to do? For example, Well Points? That would be subcontracted.

Answer: Each item bid amount should reflect the cost to JEA.

10. Question: Is there any escalation for this work. It is a 3 year with a possibility of 2 one-year extensions.

Answer: By this addendum, the Price Adjustment – Annual clause below is added to the Solicitation.

Price Adjustment - Annual

Contract rates (also referred to herein as "Unit Prices") will remain fixed through the first year (1) year of the Contract. Thereafter, the Company may request a Consumer Price Index ("CPI") adjustment annually thereafter. Only the Unit Prices for labor and equipment will be subject to price adjustment.

Each request for a price adjustment, after the first (1) year of the Contract, must be made within thirty (30) days prior to each Anniversary Date.

When a timely price adjustment request is received, JEA will recognize the price adjustment within thirty (30) days after the Anniversary Date. No retroactive price adjustments will be allowed. Price Adjustment shall be capped at 6% annually.

Unless the Company and JEA make other agreements, the annual price adjustment for the Contract shall be in accordance with the Consumer Price Index, for All items in South urban, all urban consumers, not seasonally adjusted - CUUR0300SA0 published monthly by the U.S. Department of Labor, Bureau of Labor Statistics. The index used will be the unadjusted mean average change for the previous twelve (12) months of the Company's written CPI adjustment request is received by JEA.

The calculation for the Base Date index, shall be unadjusted mean average index for the previous twelve (12) months of the Effective Date of the Contract.

In the event the applicable price index publication ceases, the Company and JEA shall mutually agree on a replacement price adjustment index. If the Company and JEA fail to agree on a replacement index, the Contract shall terminate for convenience on the next Anniversary Date. Additionally, should the applicable index deviate from market for the services or goods that are being provided, JEA in its sole discretion, may approve a request to change the applicable index and determine the method for the application of the price adjustment change.

JEA also reserves the right to decrease the Unit Prices on the Anniversary Date if justified by the CPI.
