25. Question: Spec 122+ 4x4, Response form excel line 19, 22 & 23: g=no crane, a=no crane I=no crane specs call for PTO provision. Does JEA plan on adding PTO driven equipment? With this requirement, the OEM requires the upgrade to an STX appearance group which prevents the bed delete, adds carpet, cloth interior, aluminum wheels etc. If not a real equipment requirement, please remove this item or change the spec to the chassis cab 9ft which allows a pTO provision with no additional requirements.

Answer: No, the PTO provision requirement has been removed from lines 17 – 23. JEA does not want to move up to STX package due to the increased cost.
