Questions:

1. **Question:** In column I, it says put an X next to the MPN, is that ok to be left blank if we are quoting per JEA specs? We typically order with the JEA ID as the part number.

Answer: In the response workbook most JEA Item IDs are listed multiple times – once for each approved manufacturer. This Solicitation does not have drop down menus for the MPN, instead JEA is asking that an X be entered in Column I in the row of the manufacturer being quoted. For example, using the image below, if the Supplier is quoting Ermco Trans for JEA Item ID TRACA001, enter an X in cell I8. Continue to fill out row 8 with pricing, lead time, COO, and slot quantities.
