## THIS ADDENDUM IS FOR THE PURPOSE OF MAKING THE FOLLOWING CHANGES OR CLARIFICATIONS:

- 1. Change: The bid due date has been extended to Friday, May 28th, 2021.
- **2. Question:** Can you confirm this bid is for Equipment and Materials only? It appears installation is "by others". Meaning no fieldwork is required of the supplier for the sake of this bid. Is this correct?

**Response:** Correct, this bid is for the purchase and delivery of the silencers only. Fieldwork from the supplier is not required since these are direct replacement silencers and dimensions have been provided in the bid package drawings.

**3. Question:** Who will be performing the installation? Black & Veatch? JEA? A separate sub-contractor?

**Response:** Installation of the silencers will be bid out separately to one of JEA's Qualified General Contractors.

**4. Question:** Assuming this bid is only for equipment and materials; will there be a separate bid package for field installation?

**Response:** Installation of the silencers will be bid out separately.

- **5.** Addition: JEA adds "101179 Addendum 3 Appendix C Photos" document.
- **6. Question:** Will the site be made available for a walk-down and review of the existing silencers and arrangement?

**Response:** Photos have been included in this Addendum showing the existing silencers and arrangement of Unit 2 (Unit 1 is identical). An optional field meeting will be scheduled at JEA Northside Generating Station on **Thursday, May 20, 2021 at 10:00 AM**. Viewing access is only from the outside as shown in the photos. JEA's Northside Generating Station Units 1 & 2 require a total of eight (8) PA fan silencers and four (4) SA fan silencers. Unit 1 has two (2) PA fans and two (2) SA fans. Unit 2 has two (2) PA fans and two (2) SA fans. Each PA fan requires two (2) silencers and each SA fan requires one (1) silencer. A revised table is provided in Section 15533.1.2 Performance showing the quantities of silencers per fan.

**8. Revision:** Revised table in Section 15533.1.2 in the Technical Specifications:
