2. **JEA is updating the Scope of Work as listed below.**

1.1. SCOPE OF WORK

The intent of this contract is for a one (1) year contract for the contractor to conduct maintenance services of JEA owned fire hydrants within assigned hydrant service routes in the JEA service territory, ~~and conduct hydrant flow tests for JEA owned hydrants as identified by JEA. Not all hydrants serviced will require a hydrant flow tests and this shall be taken into consideration when completing the bid form for submittal.~~ All assigned work will be grouped together geographically to reduce travel time between hydrants.

3. **JEA is updating the Minimum Qualifications and listed below**

2.1. MINIMUM QUALIFICATIONS - RFQ

The Bidder shall meet the following Minimum Qualifications to be considered eligible to submit a Bid in response to this RFQ. JEA reserves the right to ask for additional back up documentation or additional reference projects to confirm the Bidder meets the requirements stated below. A Bidder not meeting all of the following criteria may have their Bid rejected:

- Bidder must be on JEA's Responsible Bidder's List (RBL) Category GC4 – Fire Protection Equipment Installation, Maintenance and Repair by the due date of this solicitation.
