Appendix A – Technical Specifications.

SPECIAL CONDITION ITEM 900 SERIES (Creates a new item outside the scope of JEA Water and Sewer Standards)

901. MEASUREMENT AND PAYMENT

- 901.1. This section supplements JEA Section 801 for Measurement and Payment. Specifically, this specification addresses additional pay items. In the case of contradictory information, this specification takes precedence over Section 801.
- 901.2. Payment for ARV Inspection shall be at the per each unit price set forth in the Contract Documents and shall be full compensation for the item of work, complete, including all planning, labor, best management practices (BMPs), materials, tools, supplies, equipment and incidentals to inspect a single ARV, including all required permitting and traffic control.
- 901.3. Payment for Bridge Inspection Bucket Truck, shall be at the per day unit price set forth in the Contract Documents and shall be full compensation for the item of work, complete, including setup, operation, and removal of the bucket truck to inspect ARVs on bridges; and furnishing all material, labor, tools and equipment; and all incidental and related work, including permitting and traffic control, to complete the item.
- 901.4. Payment for FDOT Roadway Lane Closure shall be at the per site unit price set forth in the Contract Documents and shall be full compensation for the item of work for ARVs in FDOT roadways where lane closures are needed to access the ARV, including all required permitting and traffic control. Utilization of line item must be requested and approved by OWNER prior to work commencing. Contractor shall be paid once per site regardless of number of access attempts.
- 901.5. Payment for Exposing Deep Pipes for ARV Inspection shall be per ARV location greater than 8 vertical feet below ground surface (BGS), as measured from the ground surface to the crown of the pipe, for the purpose of inspection and back fill with sand. The quantity for this pay item shall not be exceeded without written authorization from the OWNER and shall be full compensation for the item of work, complete, including all planning, labor, best management practices (BMPs), materials, tools, supplies, equipment and incidentals to expose pipes.
- 901.6. Payment for SSO Abatement will be at per gallon rate, as collected and disposed of, by a vacuum truck. This item will include capture and disposal of sewage as directed by the OWNER. The per gallon rate has been fixed by OWNER.
- 901.7. Payment for ARV Assembly Replacement shall be at the per each unit price set forth in the Contract Documents and shall be full compensation for the item of work, complete, including all planning, labor, best management practices (BMPs), materials other than those furnished by OWNER, tools, supplies, equipment and incidentals to replace a single ARV above the isolation valve, including all required permitting and traffic control. Contractor must receive written authorization from OWNER before performing replacement. OWNER will furnish air release valve assemblies, connection piping, and fittings.
