1.2.1 MINIMUM QUALIFICATIONS FOR SUBMISSION

Bidder's **that are submitting a Bid for the Electrical Contractor Installation services scope of work, line 2 on the Bid Form** shall have the following Minimum Qualifications to be considered eligible to submit a Bid in response to this Solicitation. **JEA reserves the right to ask for additional project references and resumes to ensure the Bidder meets the Minimum Qualifications stated herein.**

It is the responsibility of the Bidder to ensure and certify that it meets the Minimum Qualifications stated below. A Bidder not meeting all of the following criteria may have their Bids rejected:

- State of Florida Electrical Contractor License

- The Bidder shall have successfully completed two (2) similar projects in the past five (5) years, date ending the Bid Due Date. A similar project is defined as an inverter & batter bank replacement project in an industrial environment with a project value greater than \$150,000.00

Please note, any Bidder whose contract with JEA was terminated for default within the last two (2) years shall have their Bid rejected.

1.2.3 NUMBER OF CONTRACTS TO BE AWARDED

JEA intends to Award up to two (2) Contract for the Work. JEA may exclude certain Work items, if JEA determines that it is in its best interest to do so. JEA intends to award each line on the Bid Form on the basis of Total Bid Price for Line 1 and Total Bid Price for Line 2. If one Bidder is the lowest price for both Lines 1 and 2, one Contract will be awarded.

Replace: the Bid Form issued with the original solicitation has been replace by the Bid Form issued with this Addendum 1. The Bid Form has been itemized to allow Bidders to Bid independently for equipment supply (UPS system equipment) and installation.
