The Awards Committee approved award Items 1 through 5. The JEA Managing Director/CEO has signed off on all of the approved awards.

Awards:

- 1. Approval of the minutes from the last meeting (December 18, 2014)
- 2. 010-15 Request approval to award a three (3) year contract to ThyssenKrupp Elevator Corp for Maintenance, Testing and Upgrades for eight (8) Traction Passenger Elevators at SJRPP, in the amount of \$1,161,228.00, subject to the availability of lawfully appropriated funds.
- 013-15 Request approval to award three (3) five (5) year contracts for the revenue projected to be paid to SJRPP for the sale of fly ash and bottom ash; 1) Primary Boral Material Technologies LLC in the amount of \$21,467,500.00; and 2) Secondary Charah, Inc. in the amount of \$13,725,000.00; and Tertiary Separation Technologies LLC in the amount of \$9,062,500.00. All are estimated award amounts which reflect the contract prices noted on the Bid Forms and are subject to the availability of the fly ash and bottom ash sales from SJRPP.
- 4. 023-15 Request approval to award a contract to Kimmins Contracting Corp in the amount of \$382,370.00 for the removal of the #6 fuel oil tank 5 at Northside Generating Station, subject to the availability of lawfully appropriated funds.
- 5. 003-15 Request approval to award a contract to Hal Jones Contractor, Inc for the removal of the four (4) berthing dolphins that remain in the St. Johns River, in the amount of \$928,118.00, subject to the availability of lawfully appropriated funds.
