Request approval to award a change order to GAI Consultants, Inc. to perform CEI (Construction, Engineering and Inspection) services for the construction inspection of the State and Union Sewer Improvement Project, in the amount of \$161,300.00, subject to the availability of lawfully appropriated funds.
- 3. 090-14 Request approval to award three (3) contracts as follows: Black & Veatch Corp (\$500,000.00), WorleyParsons Group, Inc. (\$500,000.00) and Power Engineers, Inc. (\$500,000.00) for engineering service firms with technical expertise in engineering generator and transmission Protection and Control (P&C) projects, in the total amount of \$1,500,000.00, subject to the availability of lawfully appropriated funds.
- 4. Request approval to award a contract to the developer, HYDRY COMPANY LLC, for the construction of the water main, sewer force main, reclaimed water main, in the amount not to exceed \$621,427.00, subject to the availability of lawfully appropriated funds.
- 5. Request approval to award a contract to Sensus USA Inc. for inventory purchasing of MTEAA620 (transmitter) in the amount of \$3,056,640.00, subject to the availability of lawfully appropriated funds.
