

AWARDS COMMITTEE MINUTES

The Awards Committee met on **March 19, 2015**, in the Conference Room, 8th Floor, JEA Tower, 21 West Church Street, Jacksonville, Florida. The Awards Committee approved award Items 1,2 and 4. The JEA Managing Director/CEO has signed off on all of the approved awards.

- 1. Approval of the minutes from the last meeting (March 12, 2015).
- 2. 033-15 Request approval to award a contract to Delta Star, Inc. for two (2) new 20 MVA, 26.4/13.2 kV power transformers for the new Jaxport Substation and one (1) new 8.6 MVA, 13.2/4kV power transformer for the McDuff Substation Rebuild project, in the amount of \$1,628,510.00, subject to the availability of lawfully appropriated funds.
- 3. **DEFERRED** Request approval to award a contract to HP Bruce UTZ for refresh legacy hardware and software that is not associated with an Essential Business system project in the amount of \$1,100,000.00, subject to the availability of lawfully appropriated funds.
- 4. Request approval to award a contract to Mike Davidson Ford for the purchase of sixty-one (61) trucks utilizing the Tallahassee Contract # 2518 for a total amount of \$1,825,303.72 broken down as follows: Electric Capital Replacement is for thirty-seven (37) trucks at a cost of \$834,640.36; Water Capital Replacement is for twenty-four (24) trucks at a cost of \$990,663.36, subject to the availability of lawfully appropriated funds.
- 5. **DEFERRED** Request approval to award a three (3) year contract to Electric Supply Inc. for wire and cable for JEA storeroom stock in the amount of \$4,553,892.43, subject to the availability of lawfully appropriated funds.
