- 1. Approval of the minutes from the last meeting (May 7, 2015).

- 3. Request approval to award a contract to Analytics Partners, Inc. for the upgrade of the Oracle Business Intelligence Platform, in the amount of \$172,800.00, subject to the availability of lawfully appropriated funds.
- 4. 064-15 Request approval to rescind the Solicitation for Materials for the Commercial Meter Change Out Project and reject all bids in anticipation of rebidding.
- 5. Request approval to award a contract to Sensus USA Inc. for the inventory purchasing of commercial water meter rebuild kits in the amount of \$1,052,314.73, subject to the availability of lawfully appropriated funds.
- 6. Request approval to award a contract to Sensus USA Inc. for the inventory purchasing of commercial water meters in the amount of \$2,167,095.22, subject to the availability of lawfully appropriated funds.
