The Awards Committee approved award Items 1 through 4, deferred Item 5 and approved Item 6. The JEA Managing Director/CEO has signed off on all of the approved awards.

- 1. Approval of the minutes from the last meeting (July 16, 2015).
- 2. Request approval to increase funds in the amount of \$350,000.00 to Black and Veatch Corporation to support a residential demand rate pilot, for a new not-to-exceed amount of \$750,000.00, subject to the availability of lawfully appropriated funds.
- 3. Request approval to award a change order to Burns & McDonnell Engineering Co in the amount of \$500,000.00, for a new not-to-exceed amount of \$800,000.00, for engineering support to JEA's Electric Transmission and Distribution (T&D) Planning group in regards to PSS/E stability and steady state analysis, subject to the availability of lawfully appropriated funds.
- 4. Request approval to award a contract in the amount of \$1,273,170.00 to Callaway Contracting, Inc. for construction services for the Timuquana Rd at Ortega River FM replacement project, subject to the availability of lawfully appropriated funds.
- 5. **DEFERRED** Request approval to award a contract to Sawcross, Inc. for construction of the Mandarin WRF Headworks Channel Rehabilitation, Headworks Bar Screen Replacement and Grit System Removal, and Bio Filter Bed Replacement projects in the amount of \$5,093,345.00, subject to the availability of lawfully appropriated funds.
- 6. Request approval to award a second three (3) year renewal to extend the current contract to Public Financial Management in the amount of \$1,205,000.00 for a new not-to-exceed amount of \$4,250,000.00, subject to the availability of lawfully appropriated funds.
