- 5. 048-15 Request approval to award a contract for tools and related items to HD Supply Power Solutions in the amount of \$1,523,985.86 and Miller Bearings in the amount of \$44,617.70, subject to the availability of lawfully appropriated funds.
- 6. **PULLED** Request approval to award a change order to Cintas Fire Protection for fire inspections, maintenance and testing at St. Johns River Power Park, in the amount of \$200,000.00, subject to the availability of lawfully appropriated funds.

Request approval to piggyback off of an existing HGAC unit price contract, for the rehabilitation of existing gravity sewer mains by CIPP Method and existing manholes, to award a contract to PM Construction & Rehab, LLC in the amount of \$1,639,572.00 subject to the availability of lawfully appropriated funds.
