- 1. Approval of the minutes from the last meeting (May 5, 2016) **Approved.**
- 2. 055-16 Request approval to award a five (5) year contract to Unitherm Inc., for lagging and insulation services at JEA's electric generating facilities, in the amount of \$3,247,962.50, subject to the availability of lawfully appropriated funds. **Approved**.
