- 1. Approval of the minutes from the last meeting (03/08/2018).
- 2. Request approval to award a change order to CPH Inc., for the Otter Run Water Treatment Plant Renewal and Replacement project in the amount of \$64,860.00 for a new not-to-exceed amount of \$381,891.00, subject to the availability of lawfully appropriated funds. **APPROVED**
- 3. 065-18 Request approval to award a three (3) year contract to Cook Electrical, Inc., for fiber optic cable overhead construction repair and maintenance work in the amount of \$966,360.00, subject to the availability of lawfully appropriated funds. **APPROVED w/Discussion**

- 6. Request approval to award a contract increase to Godwin Pumps of America for pump rental services in the amount of \$300,000.00, for a new not-to-exceed amount of \$959,999.90, subject to the availability of lawfully appropriated funds. **APPROVED w/Discussion**
- 7. Request approval to award a contract to Orlando Freightliner for the purchase of four (4) Class-8, Tandem Axle (6X4), Dual Rear Wheel, Standard Cab, fourteen (14) to sixteen (16) cubic yard dump trucks in the amount of \$532,620.00, subject to the availability of lawfully appropriated funds. **APPROVED w/Discussion**

8. Request approval to award a change order to Henkels & McCoy, Inc. to reflect the completion of the design work from thirty percent (30%) to 100%, and the addition of two (2) capacitor bank installations to the project in the amount of \$1,287,630.49, for a new not-to-exceed amount of \$2,211,170.70, subject to the availability of lawfully appropriated funds. **APPROVED** w/Discussion
