- 5. 073-18 Request approval to award a five (5) year contract to Merrell Bros., Inc. to remove residuals and sludge cake from the various WRFs, and haul and dispose of them at one of three locations; 1) the Buckman WRF for further processing, 2) to several Contractor permitted and regulatory approved land application sites, or 3) sanitary landfill disposal in the amount of \$3,291,555.20, subject to the availability of lawfully appropriated funds. **APPROVED**
