

Background/Recommendations:

JEA originally solicited by Request for Proposal (RFP) and informally awarded a six (6) month small scale (2,000 meter) Proof of Concept (POC) to the open market in which six (6) Respondents were scored and qualified. Three (3) Respondents (Badger Meter, Inc., Sensus USA, and Landis + Gyr) were shortlisted to participate in the POC.

The POC was completed in July 2022 and all three Respondents were then qualified to participate in the large scale ITN #1410746046 which was advertised on 07/06/2022. The three (3) POC qualified Companies attended the optional pre-response meeting held on 07/15/2022. At Response opening on 08/09/2022, JEA received three (3) Responses. The Responses were evaluated on price, use cases, solution design and architecture, design approach and work plan, ability to meet project requirements, and company experience. JEA evaluators shortlisted Badger Meter, Inc. and Sensus USA and then solicited Best and Final Offers (BAFO). Original Bid Amount was \$58,779,422,28; BAFO was \$56,364,950.70 which is \$2,414,471.58 (4.1%) savings. Service unit pricing shall be fixed for all ten (10) years and endpoint hardware shall be fixed four (4) years. Any price increases thereafter are tied to Consumer Price Index ("CPI") annual adjustments. In addition, JEA negotiated value added concessions with Badger Meter, Inc. including but not limited to improved initial endpoint delivery times. Badger Meter, Inc. is deemed the highest ranking responsible and responsive Respondent. The proof of concept (POC) results are attached as back-up. Badger Meter's solution was also reviewed and approved by JEA Information Security. A summary of the POC, a copy of the ITN evaluation matrix summary, and Response workbook are attached as back-up.

The implementation of a new Water AMI System will benefit JEA's customers. The expected Customer Service and satisfaction improvements are:

- Increased ability to detect and prevent water theft;
- Improved ability to detect water leaks and thereby decrease unaccounted water;
- Better availability to customers to manage consumption by provision of online meter readings;
- Increased bill accuracy and thus decrease high bill complaints, and
- Reduced reliability on manually obtained reads

This request is for ten (10) years from 10/01/2022 to 09/30/2032, in the amount of \$56,364,950.70. This award request also includes a twenty (20) year warranty on the solution endpoints and service level agreement of 99% network uptime. Compared to the other solutions, the Badger solution received the highest evaluation scores primarily due to no requirement for JEA to install, operate or maintain network devices, the use of ubiquitous cellular LTE communication strategy (could be transitioned into a future JEA Private LTE network), the maturity of the endpoint and customer portal, and the high performance of the technical staff and interface with JEA IT personnel and systems.

The overall implementation period for this award is expected to span 48 months. Of this period, approximately 4 - 9 months will be dedicated to the "Initial Deployment," encompassing project planning, systems architecture design and configuration, integrations, network stand-up, and a limited deployment of meters. The number of meters to be installed during the Initial Deployment is yet to be determined by JEA. JEA expects that all software configurations, integrations, and training will be complete during the Initial Deployment. The remaining 39 - 44 months will be dedicated to "Full Deployment." During Full Deployment, Company will be expected to deliver endpoints necessary for the installation of meters and resolve any FAN or HES issues discovered during this time. JEA is planning to publish a separate solicitation for the installation of endpoints immediately following approval of this award.

Note a significant value add for Badger meter uses ORION Cellular technology. JEA will not have to install or manage network infrastructure. Unlike traditional fixed network solutions in the other responses, the BEACON solution does not require the purchase, licensing, installation, or maintenance of network infrastructure, such as collectors, routers and repeaters. Instead, we utilize existing secure network

infrastructure from our Cellular Partners, who maintain all elements and absorb all costs associated with operating and maintaining the network. As a result, JEA has access to one of the largest and most robust cellular networks in North America.

The award amount is approximately \$6,364,950.70 higher than the budget estimate. The \$50M budget was derived using an endpoint price of \$75 (Badger's bid was \$80) and a read rate of \$0.30 per meter per month (Badger's bid was \$0.40). JEA has completed a capital budget transfer into the capital budget account 736-08 to cover the additional funds needed for this project.

I. Scope of Work

 Company shall provide various garments that are HRC 2 FR Clothing for all JEA electric employees, but mainly at our Westside and Southside Service Centers (approximately 150 Employees but this quantity may increase).

1. Tyndale's Response:

Tyndale has quoted CAT 2 flame resistance (FR) garments for eligible JEA employees at the locations above. Please note, the 2015 edition of NFPA 70E eliminated the term hazard risk category (HRC), replacing it with the term PPE Category (CAT). We understand that the quantity and locations may evolve.

2. The Clothing shall have a minimum Arc Rating of 8 Cal/Cm². All shirts should have a material weight of 9 oz. or less and all pants should have a material weight of 14 oz. or less.

2. Tyndale's Response:

Clothing quoted has a minimum arc rating of 8Cal/Cm². Shirts have a material weight of 9oz. or less and pants have a material weight of 14 oz. or less. Please find product details in *Attachment 1: Tyndale's Proposed Catalog for JEA*.

- 3. The Clothing shall be broken down into the following categories:
 - a. Long Sleeve T-shirts (No Collar)
 - b. Henley Shirts (Long Sleeve Only)
 - c. Button Down Shirts (Long Sleeve Only)
 - d. Polo Shirts (Long Sleeve Only)
 - e. Jeans/Denim Pants
 - f. Cargo Pants
 - g. Dress/Work Pants
 - h. Sweatshirts/Light Jackets (Pullover, Zippered, Hooded, or Non-Hooded)

3. Tyndale's Response:

Tyndale's formal quote, provided as *Attachment 2: Tyndale's Pricing for JEA*, has products broken down as specified above. In addition to the categories listed above, Tyndale has quoted balaclavas, gaiters, and hats for JEA's consideration. Only items approved by JEA management are available for employees to purchase. The product catalog can be customized to distinct groups depending on budgetary, image, and safety requirements.

- 4. Employees will provide company with a printed voucher to be used to purchase JEA-approved FR clothing items from vendor. It is the responsibility of the vendor to collect payment from employees for any cost beyond the allowances set forth by JEA. By accecting the JEA voucher the vendor agrees to the following:
 - a. The voucher may only be used to purchase JEA-approved FR clothing items. Any unapproved items will not be authorized for payment using the voucher.
 - b. The voucher will be valid between October 1st and March 31st for each fiscal year. Any invoices submitted outside of valid date range will not be paid. Date ranges are; FY23 10/01/2022 through 3/31/2023, FY24 10/01/2023 through 3/31/2024, and FY25 10/01/2024 through 3/31/2025.
 - c. The vendor may choose to allow employees to use voucher on one visit, or to allow for multiple visits during the valid date range period.
 - d. All items ordered must be shipped within 90 days of order date.
 - e. Vendor is responsible for all tracking of voucher remaining balances and submitting invoices for the shipped/issued items.
 - f. The vendor will invoice JEA monthly for the purchases made during the previous month including all of the required information listed below:
 - 1. Employee Name

- 2. Employee ID Number
- 3. Date of Sale
- 4. Itemized listing of purchases with cost and ID/Catalog Number
 - 5. Total amount of Sale
 - 6. Remaining voucher balance

4. Tyndale's Response:

Tyndale's comprehensive solution is automated and web-based; therefore, there is no need to utilize printed vouchers to track allowance purchases. During implementation, JEA specifies allowance amounts for employees – various groups can have unique allowance amounts and product assortments based on budgetary, image, or safety requirements. The employee's allowance balance is prominently displayed on the online ordering website when they log in. The allowance balance is updated in real time as purchases are made, ensuring accuracy and strict budgetary control. Employees may only buy beyond the company funded allowance by providing a personal payment method, making payment directly to Tyndale. Your dedicated account management team can provide leftover allowance reports on a regular basis or as requested so JEA management can monitor how employees are spending their funds.

- a. Only items approved by JEA management are available for employees to purchase using their JEA-funded allowance. Employees may only buy beyond the company funded allowance by providing a personal payment method, making payment directly to Tyndale.
- b. Tyndale understands that the allowance is valid between October 1st and March 31st for each fiscal year (specified above). Please note that invoicing takes place after an item ships; therefor, invoicing for items ordered towards the end of the ordering window would be invoiced after March 31st.
- c. Online purchases using the JEA-funded allowance can be made all at once using the full allowance amount in one order or as needed throughout the valid allowance period. All purchases are tracked, and the allowance balance is updated in real time to ensure strict budgetary control.
- d. Products are shipped within 90 days but typically less due to our deep on-hand inventory and sophisticated forecasting. Estimated Ship Date (ESD) is quoted for each item before the order is finalized so employees know when to expect their products. If employees need clothing quickly, they simply activate Tyndale's In-Stock filter to shop program items that are on our shelves and available to ship quickly typically within seven (7) days. Products can be delivered to the employee's home or work address depending on JEA's preference.
- e. Tyndale tracks all allowances and purchases through our automated allowance management system to ensure strict budgetary control. JEA is only invoiced for products that ship. Tyndale's statement billing, whereby we submit a single monthly invoice for all shipments that occurred within the previous month, is the most popular billing option. We are happy to work with JEA to establish appropriate invoicing during implementation.
- f. Tyndale's automated allowance management system maintains a complete profile of each eligible employee, containing all the requirements listed and additional details:
 - 1. Employee's name
 - 2. ID number
 - 3. History of allowance purchases including an itemized list of products with pricing, date of sale, and total amount of sale.
 - 4. Remaining allowance balance
 - 5. Plus, work location, job classification, and sizing statistics.

The profile allows for simple access to all account information, ensuring that all employee purchases are tracked and reported. Reports can be provided via email by your dedicated account management team on a regular basis or as requested.

5. Company can either be LOCAL retailers with brick and mortar locations within 60 miles of Jacksonville, Florida, or ONLINE retailers using an online store with a catalog of JEA approved items.

5. Tyndale's Response:

Tyndale's solution for JEA is based exclusively online. Employees use Tyndale's custom website to check allowance balances, view order history, place orders, check stock, check the status of an order, track a shipment, and more – anytime, 24 hours a day, seven days a week. A video demonstration of our website is available <u>here</u> and additional details are provided below:

- The online catalog displays only items that employees are authorized to purchase, and all products are vetted by Tyndale for safety compliance, quality, and reliable delivery before they're offered for your company's consideration.
 - Customize online catalog offerings to the needs of distinct groups within your organization. You can easily restrict which workers wear which products, according to budgeting, protective needs, and image requirements.
 - Comprehensive information is displayed for each product description, size range, color(s), fabric content as well as photos, care instructions, and manufacturer-specific information. Users can even filter products by various categories gender, attribute, brand, color, fabric, size, and more.
 - Tyndale's 800 number is displayed prominently on the website to encourage employees to deal directly with Tyndale and avoid lost work time.
- A web-chat feature as well as a helpful video guide are available on the login page to assist employees with accessing their Tyndale accounts.
- All products include user-generated product ratings and reviews, a powerful tool enabling workers to choose products based on peer feedback.
- Employees know when to expect their products. Once color, size, and logo requirements are selected, an Estimated Ship Date (ESD) is quoted for each item before the order is finalized. 5. The Company shall provide a catalog or link to an online store of all men's and women's garments that are available at the time of the Proposal that can be offered which meet the requirements/categories listed in items 2 & 3.

5. Tyndale's Response:

Please find the catalog of men's and women's garments proposed in *Attachment 1: Tyndale's Proposed Catalog for JEA. Attachment 2: Tyndale's Pricing for JEA* includes estimated on-hand inventory levels for products quoted that meet the requirements listed in items 2 and 3. Each category contains garments currently in inventory. While program implementation can take several weeks, allowing time for the onsite Tyndale 360° event (further described in section II #1 below), however, products are typically available quickly.

6. JEA shall require embroidery on all of the shirts, using FR Thread for this embroidery, including bobbins and backing. This shall include a provided JEA logo (approx. 2.5" W x 1" H) on the upper left chest.

6. Tyndale's Response:

Tyndale understands JEA's requirement for all shirts to be embroidered on the upper left chest. Tyndale uses FR thread for logo embroidery on all FR garments. The backing is cut away as much as possible and is on the inside of the garment, meaning it's protected by the FR clothing fabric itself. Bobbins use FR thread as well.

7. All expenses for fitting, embroidery, set up fees, return processing, shipping and delivery shall be included in the unit price of the clothing item billed to JEA by the Company.

7. Tyndale's Response:

Tyndale's pricing is inclusive of all key services: Tyndale 360° Events (formerly known as "fittings"), program set up fees, hassle-free returns and exchanges, individualized delivery, and more. As requested, Tyndale has also included embroidery and shipping costs in the unit prices quoted in *Attachment 2: Tyndale Pricing for JEA*. Please see Pricing Notes for additional details.

8. Order errors due to mistakes by JEA can be exchanged for a maximum of a 20% restocking fee. Restocking fees shall be invoiced separately on a monthly basis, listing employee's name and order number for related fee. Order errors due to mistakes by the Company shall be exchanged for no additional cost to JEA.

9. Tyndale's Response:

Returns with Tyndale are quick, easy, and free. JEA employees can return an unwashed, unworn, unaltered, and unembellished item to Tyndale within 60 days for virtually any reason. Tyndale does not charge JEA for return shipping or restocking fees.

- To return an item, the employee simply logs into the online ordering website and prints a return shipping label, or contacts Tyndale Customer Service to request a label, for eligible items. From there, the employee encloses the return in a shipping container, affixes the no-charge shipping label to the outside, and passes the shipment along to UPS.
- Employees may even return logoed items. If JEA chooses to allow returns of embellished garments, Tyndale requests including consignment provisions for handling logoed inventory in the contract. These provisions were included in the redlines submitted to Rodney Lovegren on 8/23/22.
- Employees receive their replacement products or account credit promptly typically within two business days from receipt at our distribution facilities.
- Employees may also request basic repairs, repair kits, and routine alterations of select items free of charge.
- 10. JEA will provide a list of JEA employee's and their Badge numbers for those personnel that are authorized to make purchases from the approved supplier location.

10. Tyndale's Response:

Tyndale looks forward to receiving a roster of eligible JEA employees and asks that email addresses and appropriate allowance amounts are also included.

II. Company's Responsibilities During Term of the Contract

1. Any ONLINE Company shall be required to make two (2) on-site visits on a mutually agreeable time to each of the electric distribution service centers for sizing of the employees, as well as providing a sample of each of the products approved by JEA for employee use.

1. Tyndale's Response:

Tyndale agrees to provide one in-person Tyndale 360° Event, further described below, at qualifying locations (with 25 employees or more) and can offer an additional virtual event each year. The Tyndale 360° Experience was created to streamline our traditional "onsite fittings" and provide a complete service to assist employees with all aspects of the program, garments, and care/maintenance. Correct fit and comfort is paramount when choosing the correct FR clothing, which can save lives in the event of an arc flash. For in-person events:

- Tyndale works with you to determine the best time and place to hold your Tyndale 360° event. Tyndale recommends having the event at a centralized hub location.
- Tyndale Field Sales Representatives bring a sampling of garments specific to your program for employees to view style, fabric, and fit prior to ordering.
- During this time, representatives are available to answer any questions wearers might have related to your company's program and/or garment selection. These representatives also provide general information regarding garment care and maintenance.

The virtual format for Tyndale 360° events offers all the same benefits as the in-person experience while maintaining safety protocols.

- We schedule an online meeting with employees, and they join virtually.
- We provide the same educational information as we would during traditional in-person Tyndale 360° events.
- Our comprehensive tools make it easy to outfit workers effectively without any in-person contact.
- 2. Any JEA employee who misses the scheduled days for fitting shall use a sample kit containing common sizes and styles for fitting at a JEA facility and enter their order using the company's online catalog.

2. Tyndale's Response:

Tyndale understands that not all employees are able to attend the in-person or virtual events. Fortunately, JEA can purchase a sample kit containing select program garments in various sizes so employees can view the products before ordering. These sample kits can be returned to Tyndale for credit as long as the

garments are in saleable condition. Additionally, Tyndale's website includes product videos for select garments and user ratings and reviews from other wearers who have purchased the product. These resources along with sizing charts, how-to measure videos, and more ensure employees make informed purchasing decisions and maximizes satisfaction.

3. The Company shall provide a JEA specific catalog that preferably is available online, and shall offer detailed listings of all JEA approved FR apparel, including pricing, arc rating, weight, and designated color options for each style.

3. Tyndale's Response:

Comprehensive information is displayed for each product in JEA's custom online catalog – including pricing, arc rating, weight, description, color(s), size range, fabric content – as well as photos, care instructions, and manufacturer-specific information. Users can even filter products by various categories – gender, attribute, brand, color, fabric, size, and more.

4. The company shall provide a detailed website that has a customizable dashboard that shows real-time information that can be filtered and searched by individual employees or departments. JEA shall have the ability to provide designated users "administrative" access to view/mange this dashboard. The information available shall include detailed records of orders, charges, amount spent/available, shipping times, and historical data for popular items, costs, average shipping times by item, etc.

4. Tyndale's Response:

Tyndale's user-friendly website has a customizable landing page that employees must view before they continue to the dashboard which features links to the catalog, specific product types (like shirts and pants), programs (if employees have access to different programs), and cart. The landing page can be edited by your account management team to include messages to employees about new items, logos, etc. and can be updated as requested. On the dashboard, employees can also choose to view their account profile, orders and returns, submit ratings and reviews for products purchased, and access resources (sizing, care and maintenance, and more). Once JEA employees select to shop items in their catalog, they can see their remaining balance amount and allowance expiration date, and filter products by various categories – gender, attribute, brand, color, fabric, size, and more.

Tyndale's Supervisor Portal allows administrative users to place orders on behalf of multiple employees, view employee information, and check employee account status. JEA's dedicated account management team provides detailed reports for JEA on a regular basis or as requested, including the information requested above: detailed records of orders, charges, amount spent/available, shipping times, and historical data for popular items, costs, average shipping times by item, etc.

5. The Company shall be responsible to separate all orders by JEA employee for either pick up or delivery to employee's home address. The invoices shall detail the employee name, employee #, item description, and cost. All invoices shall be sent electronically to a designated JEA employee for all purchases related to this Contract.

5. Tyndale's Response:

Tyndale can deliver orders to employees' home or work address, depending on JEA's preference. Tyndale offers invoices in either summary or detailed formats. The detailed invoice provides complete order activity by month for every employee. JEA chooses the criteria for organizing the data – by department, location, job title, or other criteria requested by JEA. These invoices include the employee's name, employee number, item description, and pricing. Tyndale can send invoices electronically to a designated JEA employee for all purchase related to the contract.

6. The Company shall handle all returns with employees due to product defect directly with the manufacturer, and shall credit employee's account or replace any defective items determined to be the result of a manufacturing error. JEA has the right to remove any item from the approved catalog at any time due to durability or quality concerns.

6. Tyndale's Response:

When purchasing from Tyndale, you can feel confident that items are free of defects. Our robust vetting procedures and quality assurance process ensures only the highest quality products are offered and sent to

your employees. Our unique position as a manufacturer and distributor allows us to warrant all garments against manufacturing or fabric defects for the useful life of the garment. Whether manufactured by Tyndale or one of our suppliers, Tyndale repairs or replaces any garment at no charge that is determined at Tyndale's sole discretion to have a manufacturer's defect. In the rare event of a defect, Tyndale replaces the garment and deals directly with the garment manufacturer on your behalf.

JEA can remove any product from the program for any reason and Tyndale can even suggest a comparable alternate if requested.

7. The Company shall offer repair services for additional costs, for rips or tears that are determined can be fixed. FR thread shall be used for these repairs and an estimate shall be given prior to any repair work being performed.

7. Tyndale's Response:

Tyndale offers complimentary basic repairs – such as fixing minor tears, holes, or seams – repair kits, and routine alterations of select items. For complex repairs, such as replacing a zipper on non-Tyndale items, there's a \$20 per hour fee. Repairs and alterations of FR clothing are made using FR thread and repair kits contain FR thread. If the repairtakes more than an houror the garment is worn and should be retired from service Tyndale does not perform the repair. Tyndale contacts the employee if this is the case for a garment sent in for repair services.

8. The minimum order for this bid shall consist of at least three (3) shirts and three (3) pants per employee (estimated 450 Shirts & 450 Pants initially). After that there shall be an anticipated replacement of ninety (90) additional shirts and forty-five (45) additional pants depending on wear and damage to the existing clothing. These numbers could increase if additional people are added to the department and/or if there is a greater than anticipated need for replacement garments.

8. Tyndale's Response:

Tyndale understands that JEA intends to order at least three (3) shirts and three (3) pants per employee – estimated 450 shirts and 450 pants initially. After that, Tyndale understands that JEA anticipates replacement orders of ninety (90) additional shirts and forty-five (45) additional pants depending on anticipated wear and damage to the existing clothing. Tyndale understands that these estimated quantities are subject to increase. It is typical for employees to receive a higher allowance amount for the initial period to account for the higher quantity order. Then, in subsequent periods, employees receive a lower allowance amount. Alternatively, Tyndale can offer an allotment program, which is quantity based, instead of dollar based. Allotments can also decrease after the initial year.

9. Replacement garments shall not be paid for with the initial payment from JEA. These shall be handled on an as needed basis and shall be invoiced monthly. Invoice must list employee's name and items replaced. The replacement clothing shall be paid for by JEA using a JEA purchasing card, and must be approved by designated JEA personnel.

9. Tyndale's Response:

Tyndale understands that replacement garments are not paid for with the initial payment from JEA. Tyndale is happy to provide monthly statement billing. Our detailed invoices include employee name and order details. If JEA would like to have oversight and approval of purchases made after the initial year, Tyndale can set up supervisor approval. In this type of program, the employee orders their replacement garments from the online ordering website, which only displays items which have been approved by JEA, using their JEA allowance or allotment. However, their order would not begin processing until it was approved by their supervisor in the Supervisor Portal. JEA Supervisors would log in and approve pending orders from their employees and then Tyndale would begin processing the order. Generally, supervisor approval is not necessary because the catalog only contains approved items and employees cannot purchase beyond their allowance or allotment without providing a personal payment method.

10. The vendor will invoice JEA monthly for the purchases made during the previous month including all of the required information listed above.

10. Tyndale's Response:

Tyndale can provide monthly statement billing for all purchases made during the previous month that include the details requested.

Background/Recommendations:

Advertised on 12/30/2019. Seven (7) prime contractors attended the optional pre-response meeting held on 01/06/2020. At response opening on 01/28/2020, JEA received five (5) Responses. JEA evaluated the companies on price, company experience, design approach, safety and JSEB criteria. All five (5) companies were invited to submit Best and Final Offers (BAFO) but only one (1) reduced their pricing. JEA intends to award three (3) contracts based on the budget estimate as follows: fifty percent (50%) of the award amount to the highest evaluated company, thirty-five percent (35%) to the second highest ranked company, and fifteen percent (15%) to the third ranked company. NRC Gulf Environmental Services, Cliff Berry Inc. and Hulls Environmental Services Inc. were deemed the highest ranked Responsible Respondents. A copy of the Response Forms and Workbooks are attached as backup.

An accurate price comparison between the current contract and the new contract could not be completed due to workbook item changes. The workbook was modified and improved after auditing invoices to increase pricing transparency and to capture items that were not included in the past. In the previous solicitation, the services were broken out by types of waste. Upon analysis of invoices, it was decided to categorize the rates and equipment by Emergency and Non-Emergency Waste disposal. Because the bid

criteria was changed so dramatically, a normalized comparison would not have shown an accurate cost comparison. The rates will remain fixed for the three (3) year contract term.

Procurement tracks two different types of savings. The total cost difference is comparing the current pricing with the proposed pricing (+/-). The total sourcing savings is determined by negotiations, BAFO savings and value added savings. Below is the result for this award:
