**NOTE FOR CAPACITY FEES**

Capacity fees are based on tariff minimum (indicated) or calculated value using Fixture Count, whichever is greater.

A Growth Capacity Fee is applicable, if service address does not have an existing potable water/sewer service connected.

A \$25.00 Re-Trip fee will be assessed when installation requires more than one visit due to site conditions. The fee will appear on the JEA billing statement.

All residential services with alternative water sources require a backflow device installed on the potable service and failure to comply may result in disconnection of service. By signing this form, you are giving JEA access to test and maintain the backflow device(s) on your premises. The JEA customer will be responsible for the device installation and replacement if needed.
