- A drawing or sketch of the landscaping and irrigation modifications.

You will receive a notification informing you of the status of your application after it has been reviewed. Review of your application will take place within approximately two weeks of your submission being received.

### Landscape and Turf Replacement Terms & Conditions

The Landscape Transformation is designed to help residents reduce the amount of water they use to irrigate their lawn (turf) and landscape by reducing the amount of turf in your yard, introducing Florida Friendly plants and subsequently modifying your irrigation system to use less water. Following are the landscape and turf changes that are allowed.

1. All rebate applications must be submitted between October 1, 2022 and September 30, 2023.
2. Existing turf to be modified may be living or dead at the time of applying for pre-approval application. Bare earth areas with no sign of turf are not eligible.
3. Areas of your landscape that have impervious decks or patios and structures such as outbuildings or sheds cannot be counted as area for turf removal.
4. Paving stones, pavers and brick patios are permitted but must be filled with loose material. No concrete or impermeable grouting may be used to affix the pavers in place.
5. Although this program does not specify the method of turf removal, we encourage eco-friendly methods for removal.
6. The proposed area for turf removal cannot be replaced with live or synthetic turf.
7. The proposed area for turf removal requires mulch on all exposed soil surfaces. Mulch includes organic material, like pine bark or fallen leaves. Rubber bark is allowed. Decomposed granite and rubber bark must be limited to 25% or less of the total removed surface area.
8. Where appropriate incorporate Florida Friendly Plants for your area. Plant Guide - Florida-Friendly Landscaping™ Program - University of Florida, Institute of Food and Agricultural Sciences - UF/IFAS (ufl.edu)
9. Turf replacement and landscape conversion must be completed within 120 days of application approval.
10. Post Install Landscape Rebate Application must be submitted within 180 days of pre-application approval.
11. In addition to irrigation system modifications such as run times per zone, nozzle heads and addition of rain sensor and/or smart irrigation controllers, you must modify the existing irrigation system to eliminate irrigating the area where turf has been removed and reduce irrigation to areas that Florida friendly plants have been introduced.

### Process Related Terms & Conditions

1. The JEA rebate will be awarded on a first-come-first-serve basis and as program funding is available.
2. The JEA program will rebate \$1,000 for landscape transformations that meet removal of turf and irrigation system modifications.
3. Participation in the program requires that the terms and conditions for turf replacement are met. If these requirements are not met, the rebate application will be denied.
4. Submissions of altered photographs are considered a fraudulent use of the program, and will result in application disqualification. Photos which show yards which have been digitally or otherwise altered, enhanced, embellished or filtered will render an application ineligible.
5. A contractor direct rebate option is available and by checking yes in the box in the Contractor Information Section on page 1 and by signing below, I am authorizing the payment of the rebate to the named contractor and understand that I will NOT be receiving the rebate payment from JEA.
6. JEA makes no representation or warranty relating to turf replacement, including any hazardous substances that may be contained in the conversion materials.
7. Applicant waives and releases JEA and/or its designees including program administrators, contractors, or agents from any and all claims and causes of action arising out of the turf removal, re-landscaping and irrigation modifications.
8. Please allow 6-8 weeks from the date all required information is received to process your rebate.
9. You are urged to seek appropriate consultation concerning any tax liabilities that could be associated with the receipt of the rebate.
10. I understand that I may be contacted by JEA via survey or a questionnaire to provide feedback on my satisfaction with the program.
11. By submitting this rebate application, you acknowledge JEA's right to audit this application and if requested, you will allow a representative from JEA reasonable access to verify installation of qualifying product(s)
