Contractor Direct Install Toilet Replacement Rebate Form

The Residential Rebate Program provides a \$250 rebate for single-family and multi-family homes for the purchase and installation of WaterSense® labeled 1.28 GPF toilets for JEA water customers only. The toilets must be purchased brand new, must be installed by a pre-qualified contractor and must meet all program requirements. A maximum of two toilets per singlefamily service address and three toilets per unit per multi-family service address.

All rebate submissions must contain the following information in order to be processed:

1. An invoice dated between May 8, 2023 and September 30, 2023, indicating the type of equipment, purchase date, purchase price, and model. JEA rebate must be clearly indicated on the customer invoice. Please allow 6-8 weeks for receipt of rebate check.

Please ensure all fields are complete. Incomplete information could delay or disqualify your rebate.

Terms and Conditions

- Equipment and services must be purchased within one year of the installed date and installed between May 8, 2023 and September 30, 2023 by a pre-qualified contractor in a residence that receives JEA residential water service, as evidenced by the JEA bill account number.
- Rebate application must be submitted within 90 days of equipment installation. A maximum of two toilets per single-family service address and one toilet per unit per multifamily service address.
- 3. Customer must be a residential water customer of JEA.
- 4. It is the responsibility of the contractor to assure that all requirements for the rebate are met. Failure to provide any of the required information will prevent processing of your application.
- Rebate payments are based on the equipment installation date. Contractors must abide by the rules and rebate levels in effect on the date of installation. Rebate levels cannot exceed the cost of equipment and installation.
- Purchase must be a WaterSense labeled 1.28 GPF toilet and must be replacing a 1.28 GPF or larger toilet to be eligible for the rebate.
- All WaterSense labeled equipment must be listed at https:// lookforwatersense.epa.gov/products/Product-Search-Results-Toilets.html in order to participate in this program.

- 8. JEA and/or its designees including program administrators and evaluation contractors reserve the right to review installations to verify completion and measure water savings to ensure compliance with all program requirements. Such reviews will be made at a time convenient to the applicant. Misrepresentation of installation location or measure eligibility may result in forfeiture of the rebate.
- Program procedures, requirements and rebate levels are subject to change or cancellation without notice and are subject to available program funds.
- 10. Please allow 6–8 weeks from the date all required information is received to process your rebate(s).
- 11. JEA and/or its designees including program administrators, their parents, subsidiaries, affiliates, officers, employees, contractors and agents assume no responsibility for the performance of the equipment or equipment warranty, the quality of the work, labor and/or materials supplied, and/or the acts or omissions of the participating contractor.
- 12. The contractor hereby agrees to indemnify, defend and hold harmless, JEA, its parents, subsidiaries, affiliates, officers, employees and agents from any and all liability associated with this project.
- 13. I understand that I may be contacted by JEA via survey or questionnaire to provide feedback on my satisfaction with the program.
