

JEA offers rebates for blown-in fiber glass insulation. The rebate amount is \$0.20 per square foot up to a maximum rebate amount of \$200. The rebate maximum will cover the first 1,000 square feet of installation installed to achieve R-38. The attic floor must have less than 5" (or R-15) of existing insulation in order to qualify for the rebate. Rebates are available for JEA electric customers only. Rebated insulation must be installed within the JEA service territory and at the customer address provided on this form. JEA, or its trade ally, reserves the right to conduct field inspections to verify installations. All rebates are subject to terms and conditions listed below. Please allow 6–8 weeks for receipt of rebate check.

## SUPPORTING DOCUMENTS

All rebate submissions must include the following:

- Photo documentation of pre-existing R-value prior to work being performed
- Copy of invoice stating pre-existing R-value, added R-value and square footage covered
- Signed Attic Insulation consent form

## **REBATE TERMS AND CONDITIONS**

- 1. Work completed by a JEA pre-qualified contractor must be clearly indicated on the invoice and the JEA rebate must be clearly indicated as a deduction from the total price including installation.
- 2. Insulation must be installed by a pre-qualified contractor in a residence that receives JEA residential electrical service, as evidenced by the JEA bill account number.
- 3. To qualify for rebates, the R-value of the existing roof/attic insulation must be R-15 or less and the insulation installed must be R-38 or greater.
- 4. The qualified insulation must be purchased and installed by September 30, 2023. All program rebate applications must be received by October 7, 2023.
- 5. Contractor must submit (i) a completed rebate application form, (ii) a copy of the original invoice/receipt and (iii) photo documentation of pre-existing R-value taken next to a ruler. Invoice/receipt must include the R-value of the pre-existing insulation, R-value of the insulation installed, heated square footage covered and the payment terms.
- 6. Rebates will be processed and paid on a first come, first served basis. Rebate will be processed in approximately 6 to 8 weeks. Terms and conditions are subject to change without notice.
- 7. JEA and/or its designees including program administrators and evaluation contractors reserve the right to review installations to verify completion and measure energy savings to ensure compliance with all program requirements. Such reviews will be made at a time convenient to the applicant. Misrepresentation of installation location or measure eligibility may result in forfeiture of the rebate.
- 8. JEA and/ or its designees including program administrators, their parents, subsidiaries, affiliates, officers, employees, contractors and agents assume no responsibility for the performance of the equipment or equipment warranty, the quality of the work, labor and/or materials supplied, and/or the acts or omissions of the participating contractor.
- 9. The contractor hereby agrees to indemnify, defend and hold harmless, JEA, its parents, subsidiaries, affiliates, officers, employees and agents from any and all liability associated with this project.
- 10. I understand that I may be contacted by JEA via survey or questionnaire to provide feedback on my satisfaction with the program.
