




# Arriving in Atlanta: Tuesday, December 10<sup>th</sup>

- Arrive at Hartsfield-Jackson International Airport
- Transportation to Holland & Knight
  - MARTA
    - Make your way to the MARTA station within the Airport
    - GOLD line: Northbound to Doraville Station
    - Look for the Gold line and, take the northbound train towards Doraville
    - Take this train 12 stops (~24 min) to the Arts Center Transit Station
    - After exiting the train, head South on Peachtree Street
    - Cross over Peachtree, and Holland & Knight will be a block down the road on you RIGHT
    - The building sits at the corner of Peachtree and 14<sup>th</sup> Street
  - UBER or Taxi
    - To take a car, use the below address as your final destination
    - Holland & Knight, 1180 Peachtree Street NE Suite #1800, Atlanta GA 30309




## Arriving in Atlanta: Tuesday, December 10<sup>th</sup> (cont'd)

  - The Artmore Hotel will be on your LEFT at the intersection of Peachtree and 16<sup>th</sup> Street




## Departing Atlanta: Friday, December 12<sup>th</sup>
