

# Retirement Savings Plans

JEA offers very attractive retirement benefits to assist our employees in reaching their savings goals. The following is a listing of the plans:

- General Employees Defined Contribution (GEDC) Plan
  - Graduated vesting schedule for employer contributions
  - Includes disability retirement provision
  - Social Security contributions are not made since contributing to the GEDC.
  
- JEA 457 Deferred Compensation Plan
  
- JEA 401(a) Defined Contribution Plan (appointed only)

Note: the retirement plans are not extended to temporary employees
